



## 2020 ZONE 4 HANDY HUNTER CHALLENGE SPECIFICATIONS

The USHJA Zone 4 Hunter Committee has created this program to provide Handy Hunter Challenges which test skills riders and their horses might use during an enjoyable day of foxhunting combining the elements of flat and over-fences classes. A handy hunter is a horse or pony that is very easy to maneuver around a course in a ring or in the hunt field. Different elements that might be seen in a handy hunter course include, but are not limited to, fences at the gallop, rollbacks, trot fences, a gate to open and/or close from the horse's back, etc. This class may not be appropriate for a green horse/pony or a novice rider.

The USHJA Zone 4 Committee shall fund \$1,000 for each of the Children's & Adult Amateur Handy Hunter Challenges and \$500 for the Children's Hunter Pony Handy Challenges. The USHJA Zone 4 Committee shall also fund Handy Hunter Challenges at each USHJA Zone 4 Championships to include a \$2,000 3' Children's & Adult Amateur Handy Hunter Challenge and a \$1,000 Children's Pony Hunter Handy Challenge. (The two Zone 4 Championships have a total funding of \$6,000 each.) The location of these classes will be allocated for a two year term. **Participation in these classes accrues points for the USHJA Zone Horse of the Year standings and Stirrup Cup standings.**

### I. CLASS SPECIFICATIONS

- A. All challenges will be held as a one round Handy Hunter class.
- B. A minimum of ten (10) fences set at appropriate heights and spreads.
- C. Fence Heights
  1. Children's & Adult to be set at 3'
  2. Small/Medium Children's Hunter Ponies to be set at 2'
  3. Large Children's Hunter Pony to be set at 2'6".
- D. In the 3' Children's & Adult Handy Hunter Challenge, there will be three (3) high option fences set three inches (3") higher with spreads not to exceed the fence height. The course must be run in accordance with HU123.6 and include at least one (1) in-and-out, a bending line and a trot fence. The use of natural obstacles, ditches and banks are encouraged.
- E. In the Children's Pony Handy Hunter Challenge, there will be no high options. The course must be run in accordance with HU123.6 and include a bending line, a roll back turn, and a trot fence. The use of natural obstacles, ditches and banks is encouraged.

### II. ELIGIBILITY

- A. The rider and the owner (or recorded lessee) of the horse/pony must have USHJA Zone 4 as their home zone of record to participate and are eligible to compete under Zone 4 Specifications.
- B. The rider and owner must be Active members, in good standing, of both USEF and USHJA before the start of the challenges.
- C. Horses/Children's Hunter Ponies must be registered with USHJA and USEF in order to participate.

### III. RESTRICTIONS

- A. Riders may only compete on one horse/pony per Handy Hunter Challenge, but may ride in multiple Handy Hunter Challenges at the same competition.
  1. Riders may compete on one Children's Hunter Pony in each different height section offered.
- B. Horses and Children's Hunter Pony may only compete in one Handy Hunter Challenges per competition.

- C. Professionals are not eligible to compete in the Handy Hunter Challenges.
- D. All ribbon winners from qualifying Handy Hunter Challenges during the current competition year are eligible to compete in one of the Handy Hunter Challenges held at the Zone 4 HOTY Championships. The \$2,000 Children's & Adult Amateur and the \$1,000 Children's Hunter Pony prize money per class will be funded by the USHJA Zone 4 Committee.

#### **IV. JUDGING**

- A. The Handy Hunter Challenges may be officiated by one (1) or two (2) USEF "R" Hunter licensed judge(s). The judge must be in good standing with the USEF and USHJA.
- B. The Challenges at the Championships must be officiated by one (1) or two (2) USEF "R" licensed hunter judges. The two judges will be seated together and give one score.
- C. All judges must be Federation licensed and in good standing with the Federation and USHJA.
- D. The Handy Hunter Challenges shall be judged and numerically scored on quality, movement, jumping style, handiness, manners and way of going. Pace and brilliance are to be rewarded.
- E. In addition to the base score, an Option Bonus Score consisting of one additional point for every higher height option fence jumped without knock down and a Handy Bonus Score consisting of zero (0) to ten (10) bonus points to each horse-and-rider combination for handiness of round. The three scores and the sum total must be announced separately.
- F. The judge or judging panel may not award the same base score to any two competitors in the class unless a competitor's score is below the cut-off score.
- G. All ties will be broken by the base score of the judge or judging panel before adding height and/or handy bonus points.
- H. The Challenges must be a stand-alone Challenge.

#### **V. ENTRY FEE/PRIZE MONEY/AWARDS**

- A. There is no entry or nomination fee to compete in the Handy Hunter Challenge.
- B. The prize money will be funded by the USHJA Zone 4 Committee. Upon receipt of the complete results, including the prize money payouts, USHJA will reimburse the host competition for the prize money paid in the Zone 4 Handy Hunter Challenges, (up to a maximum of \$500 per Children's Pony Hunter and \$1,000.00 per Children's & Adult Amateur Handy Hunter Challenge.)
- C. The \$500 Children's Pony Hunter prize money will be distributed as follows: \$160, \$110, \$75, \$60, \$50, \$45
- D. The \$1,000 Children's & Adult Amateur prize money will be distributed as follows: \$320, \$220, \$150, \$120, \$100, \$90.
- E. The USHJA Zone 4 Committee shall also fund Handy Hunter Challenges at the USHJA Zone 4 Championships to include a \$2,000 Children's & Adult Handy Hunter Challenge and a \$1,000 Children's Pony Hunter Handy Challenge. (The two Zone 4 Championships have a total funding of \$6,000.) The location of these classes will be allocated for a two year term.
  - 1. The \$2,000 Children's & Adult Amateur Championship prize money will be distributed as follows: \$640, \$440, \$300, \$240, \$200, \$180.
  - 2. The \$1,000 Children's Pony Hunter Championship prize money will be distributed as follows: \$320, \$220, \$150, \$120, \$100, \$90.
- F. USHJA will provide a cooler for first place and ribbons for 1st-12th place funded from the Zone 4 Committee budget. The top three (3) riders (or their designated representative if they are not available) must be present for awards presentation in order to receive prize money and awards.
- G. The Zone 4 Handy Hunter Challenges do not count for USHJA Zone HOTY or Stirrup Cup "Bonus" Championship points. Regular points will be awarded for the all Zone 4 Handy Hunter Challenges including those held during the Championships, GR1131.5.

#### **VI. POINTS**

For each type of challenge USHJA Horse of the Year and Stirrup Cup points will count toward the sections listed below. No "bonus" Championship points will be awarded.

***\*\$500 Zone 4 Children's Pony Handy Hunter Challenge consists of Children's Hunter Pony S&M and LARGE combined.***

**\$1,000 ZONE 4 CHILDREN'S & ADULT AMATEUR HANDY HUNTER CHALLENGE:**

2703 - Childrens Hunter-Horse 14 & Under

2704 - Childrens Hunter-Horse 15-17

2801 - Adult Amateur Hunter 18-35 Years

2803 - Adult Amateur Hunter 36-49

2804 - Adult Amateur Hunter 50+ Years

***\*\$1,000 Zone 4 Children's & Adult Amateur Handy Hunter Challenge consists of all age groups from Children's Hunter Horse and Adult Amateur Hunter combined.***

\*Separate sections listed above by code number may not be held as individual handy hunter challenges, sections and section code numbers are only listed for the purposes of points.
