Section 1. Foundation Officers elected by the Foundation Board who cannot perform the duties of an Officer in accordance with the ethics and standards, and conflict of interest policies in accordance with the Foundation Bylaws may be removed from their Office with the majority approval of the USHJA Board of Directors. The remaining term of such Officer position shall be filled in the manner specified by the USHJA Board.
