

<u>2023 USHJA ZONE</u> CHEF D'EQUIPE APPLICATION

Thank you for your interest in serving as a USHJA Zone Chef d'Equipe. This exciting and rewarding role will assist in the development of equestrian athletes through several zone team championships held throughout the competition year. The role of the Chef d'Equipe is not to be a trainer, coach, or competition manager. The role of the Chef d'Equipe is to understand the specifications and format of the competition and be available to team members and their trainers to answer any questions concerning the event.

The job of the Chef d'Equipe also includes handling all interactions with licensed officials, competition management/staff, and USHJA representatives as it pertains to the team. The Chef d'Equipe is the overall leader and manager of athlete/horse combinations that are participating on a zone team at a championship.

To be considered for the position of Chef d'Equipe, a member must meet the eligibility requirements, complete an application, and submit it to USHJA no later than **April 1, 2023**. Interviews with the applicant's respective zone committee will be conducted for all who submit complete applications. *The number of Chef d'Equipe positions available may vary by Zone*.

APPLICANT REQUIREMENTS

- 1. Current Active Senior member in good standing with USHJA and USEF.
- 2. Agree to attend <u>one or more of the following as a multi-year contract in</u> <u>rotation with the respective host location</u>:
 - USHJA Zone Jumper Team Championship,
 - USHJA Platinum Jumper Championships,
 - USHJA 1.0m/1.05m Child/Adult Zone Jumper Championships,
- USEF Pony Jumper Championship,
- USEF National Junior Jumper Championships (Prix de States),
- USEF North American Youth Championships (NAYC).
- 3. <u>Agree to participate in one annual orientation and training session.</u>
- 4. Individuals selected to serve as team Chefs d'Equipe must have completed:
 - the annual Safe Sport Training
 - a background check within the past five years, provided the results to USHJA
 - Concussion training
 - Service Agreement
