The Hamel Scholarship for Further Education is designed to encourage further education among equestrians and will award up to \$25k to one USHJA member for college, graduate, trade or professional school. The Gochman Family Grant for the US Pony Finals offers up to three annual grants to young riders to afford them the opportunity to compete in the US Pony Finals. Zone scholarships - funds are raised by members of regional zones and awarded as educational scholarships to zone members. The Foundation's Making a Dream Grant offers unique opportunities in the hunter/jumper sport to USHJA members who face significant adversity, such as mental, physical or emotional challenges;
