Under this program, the USHJA also provides administrative services to affiliate member organizations. Along with those affiliate member organizations, the USHJA develops projects that bridge the opportunities these organizations provide at the local and state level to a national level; and to develop cohesion among the various tiers of the hunter and jumper industry for the benefit of the sport.**

Just a few of the many programs offered include the Emerging Athletes Program which provides opportunities for young riders to advance their education in their pursuit to become knowledgeable horsemen within the hunter/jumper community, the Trainer Certification Program was developed to preserve the American Hunter/Jumper Forward Riding System by offering a comprehensive educational program for professional horse trainers, and the Horsemanship Quiz Challenge which encourages education and recognizes young equestrians who have exceptional horsemanship**
