## **2021 Capital Challenge Specifications**

*Changes from 2020 marked in bold, italics and underlined.*

WCHR General Rules

WCHR Challenge Classes

1. All competitors **MUST** be 2021 members of the World Championship Hunter Rider Program prior to the start of their respective Challenge class. If a rider qualifies from the competition and is not a WCHR Program member, they may show after paying the 2021 & 2021 membership dues.

### **2. *HOTY Points and Awards***

*National and Zone HOTY points and money won (where applicable) will be awarded for placing in a WCHR Challenge Class. Horses and ponies must be eligible for the section declared at the time of entry.*

*In order for National and Zone HOTY points and money won (where applicable) to be awarded:*

- Riders must complete the USHJA Exhibitor Declaration Form prior to the conclusion of the competition for applicable Challenge Classes only (Professional and Developing Professional).*
- Declarations for the Professional Challenge class may be any one WCHR recognized 3'6" professional section.*
- Declarations for the Developing Professional Challenge Class may be any one WCHR recognized 3'3" or 3' professional section.*
- Riders may only declare one section in which to earn HOTY points or money won (where applicable).*
- The two-round stand-alone Hunter Classic point scale will be utilized when awarding National HOTY bonus points. See HUI73.9(b).*
- HOTY points and money won will only be awarded towards a declared Hunter section for HOTY points if the horse competes in the declared section a minimum of five (5) times during the current competition year.*

3. Bonus points toward 2021 WCHR National Awards will be given in the WCHR Professional, Developing Professional, Amateur Owner 3'6", Amateur Owner 3'3", Adult Amateur, Junior 3'6", Junior 3'3", Children's and Pony Challenge Classes as follows: 1st, 140 pts; 2nd, 130 pts; 3rd, 120 pts; 4th, 110 pts; 5th, 108 pts; 6th, 106 pts; 7th, 104 pts; 8th, 102 pts.

4. All WCHR points accumulated during the 2021 Capital Challenge Horse Show will be calculated and applied toward 2021 WCHR National Awards using the following increment system:

3-15 horses: 50, 40, 30, 25, 20, 15, Champion 2 x 1st place ribbon, Reserve Champion 1.2 x 2nd place ribbon.

16+ horses: 60, 48, 36, 30, 24, 18, 12, 6, Champion 2 x 1st place ribbon, Reserve Champion 1.2 x 2nd place ribbon.

Should any hunter section offer less than four over fences classes the points will be

weighted as if the section offered four over fences classes, per official WCHR Program Specifications. Developing Professionals may accumulate points in all of the Future Hunter sections.

5. The WCHR Amateur Owner 3'6" and 3'3", Adult Amateur, Junior 3'6" and 3'3", Children's and Pony Challenges will consist of one round over an open hunting type course with 10-12 fences with a minimum of one in & out and at least three oxers. The WCHR Professional Challenge and WCHR Developing Professional Challenge will consist of two rounds over an open hunting type course with 10-12 fences with a minimum of one in and out and at least three oxers. The top 12 highest scoring horse-and rider combinations from the first round will be invited back to compete over a different course. **Riders can compete on only one horse. Riders can compete on the horse of their choice; the horse does not need to be entered in any other classes at Capital Challenge.**

**\*Amateur riders competing in an Amateur Owner Challenge must compete on a horse that either they or a member of their family owns per HU136.**

6. All WCHR Challenge classes will be judged numerically by multiple teams of two judges. Each team will present one score and the scores will be averaged for a single round total. In the case of a two round class, the first and second round average will be added together for a two round total. The entry with the highest total will be the class winner. Before the start of each class one judging panel will be designated the first tie breaking team and another judging panel will be designated the second tie breaking team. In the case of a tie at the conclusion of the one round Challenge classes, the score of the first tie breaking team of judges will determine the winner. Should there still be a tie, the score of the second tie breaking team of judges will determine the winner. In the case of a tie at the conclusion of the two round Challenge classes, the second round score of the first tie breaking team of judges will determine the winner. Should there still be a tie, the second round score of the second tie breaking team of judges will determine the winner.

7. To be ridden in formal attire. To be judged on performance and soundness, suitability to count.

8. Riders not already qualified for the WCHR Challenges prior to the start of the 2021 Capital Challenge Horse Show will have points from their eligible hunter sections at CCHS applied toward qualifying for the Challenges in the following manner:

1st - 20, 2nd - 12, 3rd - 8, 4th - 4, 5th - 2, 6th - 1, 7th - 1/2, 8th - 1/4. Under saddle classes not to count.

9. Riders who qualify for a WCHR Challenge from the Capital Challenge Horse Show may compete in that Challenge regardless of their WCHR category, provided they are otherwise eligible. Riders may compete in all Challenges that they qualify for, provided they are otherwise eligible.

10. Riders will be invited to compete in their respective Challenge class based on their standings in the WCHR National & Regional Standings. The top six riders (top eight for the Amateur Owner 3'3" and 3'6") in each of the Regional Standings will be

invited to compete in their respective Challenge class. The top ten riders in the National Standings will be invited to compete in their respective Challenge class.

11. Riders qualifying from the WCHR National & Regional Standings must notify the competition of their intent to show upon receipt of the invitation to compete. Should a rider who qualified for a Challenge from the WCHR **National Standings** elect not to compete, the next rider on the **National** standings list **WILL** become eligible to compete. **In this case, invitations to compete may be extended through 14th place in the National Standings.** Should a rider who qualified for a Challenge from the WCHR **Regional Standings** elect not to compete, the next rider on the **Regional** standings list **WILL** become eligible to compete. In this case, invitations to compete may be extended through 10<sup>th</sup> place (12<sup>th</sup> place for the Amateur Owner 3'3" and 3'6") in the Regional Standings.

12. Should a rider qualify for a Challenge class both from Regional Standings and a hunter section during the Capital Challenge Horse Show, the qualification from the Regional Standings takes precedence and will be considered the official means of qualification.

13. Riders qualifying for Challenge classes from the competition must enter that class 30 minutes after the completion of their last over fences class. After close of entries additional invitations may be extended to the next qualifiers in line. The desired number of entries in each Challenge class is 25. (Exception: Developing Pro where the desired number of entries is 30.) In case of ties, entries will remain tied and additional invitations will be extended.

14. In order to be eligible for the WCHR Adult Amateur Challenge at the 2021 Capital Challenge Horse Show, riders may not have participated in any Amateur Owner 3'6" hunter section or any other hunter section where the fences exceed 3'5" (on any horse) after June 1 of the current competition year. *Note: Amateur Owner 3'3" riders are eligible for the WCHR Adult Challenge at the 2021 Capital Challenge Horse Show as long as they have not shown in a hunter section where the fences exceed 3'5" after June 1, 2021. However, a horse-and-rider combination may not cross enter between the Amateur Owner 3'3" section, and the WCHR Adult Amateur Challenge or between the Amateur Owner 3'6" section and the WCHR Amateur Owner 3'3" Challenge at the 2021 Capital Challenge Horse Show.*

15. WCHR Children's Challenge: Eligible riders may not have participated in any hunter section where the fences exceed 3'5" (on any horse) after June 1, 2021. *Note: Junior 3'3" riders are eligible for the WCHR Children's Challenge at the 2021 Capital Challenge Horse Show as long as they have not shown in a hunter section where the fences exceed 3'5" after June 1, 2021. However, a horse-and-rider combination may not cross enter between the Junior 3'3" section, and the WCHR Children's Challenge.*

16. WCHR Junior 3'3" Challenge: *A horse-and-rider combination may not cross enter between the WCHR Junior 3'3" Challenge and the Junior 3'6" section or between the Junior 3'3" section, and the WCHR Children's Challenge at the 2021 Capital Challenge Horse Show.*

## WCHR Members Only

Entries in the 2021 Capital Challenge Horse Show are restricted on a first-come, first-served basis (GR915.2a). In addition, the top five qualified riders - in the race for the 10 World Championship Hunter Rider National Awards (Professional, Developing Professional, Amateur Owner 3'6" and 3'3", Adult Amateur, Junior 3'6" and 3'3", Children's, Pony and Handy Hunter) may not be denied entry into the show, on one horse showing in a single section, as long as their entries are received before the closing date. In accordance with the WCHR program rules, a rider must ride the same horse throughout the entire hunter section, with the exception of the under saddle class, to receive WCHR points.

### World Championship Hunter Rider Leading Rider Armbands

To be distributed to the riders standing first and second in nine of the 10 WCHR National Standings at the start of the 2021 Capital Challenge Horse Show. (Exception: Handy Hunter) The leading riders are REQUIRED to wear this armband throughout their sections. Upon the completion of each day of the competition, an armband will be awarded to the new leading riders who will be REQUIRED to wear the armband during the competition the following day. The riders leading each WCHR category at the conclusion of all classes in each category are REQUIRED to wear the armband throughout their WCHR Challenge Class(es). No Entry Fee.

#### 1. \$25,000 WCHR Professional Challenge

\$25,000 includes prize money AND grooms awards.

Invitations will be extended to professional riders who finish in the top four from each of the six WCHR recognized 3'6" or higher Open Sections at the 2021 Capital Challenge Horse Show. Additionally, invitations will be extended to the top 10 nationally ranked WCHR Professionals prior to the start of the show, the top six regionally ranked WCHR Professionals from each of the eight WCHR Regions, the winner of the 2020 WCHR Professional Challenge and the 2020 WCHR Professional National Champion. Developing Professionals are eligible to compete, however, points earned in this class only count toward the Professional National Standings. See page 9 for WCHR membership criteria. Riders may compete on only one horse. This Challenge is a two-round class in which the 12 highest scoring horse-and rider combinations from the first round will be invited back for the second round. Fence heights of 3'6".

#### 2. \$2,500 WCHR Amateur Owner 3'6" Challenge

Entry Fee \$150

Twelve Ribbons: \$750; \$550; \$325; \$200; \$150; \$125; \$100; \$75; \$75; \$50; \$50; \$50

Invitations will be extended to the top eight riders from each of the Amateur Owner 3'6" sections at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top eight placings in a section, invitations will be extended to the next highest finisher(s) to ensure that eight individual riders receive invitations to compete.

Due to the Covid-19 pandemic, all USHJA programs, properties, events and related specifications are subject to change in accordance with federal, state and local laws and regulations.

Additionally, invitations will be extended to the top 10 nationally ranked WCHR Amateur Owner 3'6" riders prior to the start of the show, the top eight regionally ranked WCHR Amateur Owner 3'6" riders from each of the eight WCHR regions and the winner of the 2020 Amateur Owner 3'6" Challenge. See page 9 for the WCHR membership criteria. Riders may compete on only one horse. This Challenge is a one-round class. Fence heights of 3'6". **\*Amateur Owner riders must compete on a horse that either they or a member of their family owns per HU136.**

3. \$2,500 WCHR Junior 3'6" Challenge

Twelve Ribbons: \$750; \$550; \$325; \$200; \$150; \$125; \$100; \$75; \$75; \$50; \$50; \$50  
Invitations will be extended to the top six riders from each of the Junior Hunter 3'6" sections at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top six placings in a section, invitations will be extended to the next highest finisher(s) to ensure that six individual riders receive invitations to compete. Additionally, invitations will be extended to the top 10 nationally ranked WCHR Junior 3'6" riders prior to the start of the show, the top six regionally ranked WCHR Junior 3'6" riders from each of the eight WCHR regions and the winner of the 2020 WCHR Junior 3'6" Challenge. See page 9 for WCHR membership criteria. Riders may compete on only one horse. This Challenge is a one-round class. Fence heights of 3'6".

4. \$2,500 WCHR Junior 3'3" Challenge Entry Fee \$150

Twelve Ribbons: \$750; \$550; \$325; \$200; \$150; \$125; \$100; \$75; \$75; \$50; \$50; \$50  
Invitations will be extended to the top six riders from each of the Junior Hunter 3'3" sections at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top six placings in a section, invitations will be extended to the next highest finisher(s) to ensure that six individual riders receive invitations to compete. Additionally, invitations will be extended to the top 10 nationally ranked WCHR Junior 3'3" riders prior to the start of the show and the top six regionally ranked WCHR Junior 3'3" riders from each of the eight WCHR regions and the winner of the 2020 WCHR Junior 3'3" Challenge. See page 9 for WCHR membership criteria. Riders may compete on only one horse. This Challenge is a one-round class. Fence heights of 3'3". *Note: Junior 3'3" riders are eligible for the WCHR Children's Challenge at Capital Challenge as long as they have not shown in a hunter section where the fences exceed 3'5" after June 1, 2021. However, a horse-and-rider combination may not cross enter between the Junior 3'3" section, and the WCHR Children's Challenge or between the Junior 3'6" section and the WCHR Junior 3'3" Challenge at the Capital Challenge Horse Show.*

5. \$2,500 WCHR Pony Challenge

Twelve Ribbons: \$750; \$550; \$325; \$200; \$150; \$125; \$100; \$75; \$75; \$50; \$50; \$50  
Invitations will be extended to the top four riders from each of the Pony Hunter sections at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top four placings in a section, invitations will be extended to the next highest finisher(s) to ensure that four individual riders receive invitations to compete. Additionally, invitations will be extended to the top 10 nationally ranked WCHR Pony riders prior to the start of the show, the top six regionally ranked WCHR Pony riders from each of the eight WCHR regions and the winner of the 2020 Pony Challenge. See page 9 for WCHR membership criteria. Riders may compete on only one pony. This Challenge is a one-round class. Fence heights of Small-2'3", Medium-2'6", Large-2'9"-3'0"

6. \$2,500 WCHR Adult Amateur Challenge

Entry Fee \$150

Twelve Ribbons: \$750; \$550; \$325; \$200; \$150; \$125; \$100; \$75; \$75; \$50; \$50; \$50  
Invitations will be extended to the top six riders from each of the three age groups of the Adult Amateur Hunters at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top six placings in a section, invitations will be extended to the next highest finisher(s) to ensure that six individual riders receive invitations to compete. Additionally, invitations will be extended to the top 10 nationally ranked WCHR Adult Amateur riders prior to the start of the show, the top six regionally ranked WCHR Adult Amateur riders from each of the eight WCHR regions and the winner of the 2020 WCHR Adult Amateur Challenge. See page 9 for WCHR membership criteria. Riders may compete on only one horse. In order to be eligible for the WCHR Adult Amateur Challenge at Capital Challenge, riders may not have participated in the AO3'6" hunter section or any other hunter section where the fences exceed 3'5" (on any horse) after June 1 of the current competition year. This Challenge is a one-round class. Fence heights of 3'0". *Note: Amateur Owner 3'3" riders are eligible to qualify for the WCHR Adult Amateur Challenge at Capital Challenge as long as they have not shown in a hunter section where the fences exceed 3'5" after June 1, 2021. However, a horse-and-rider combination may not cross enter the Amateur Owner 3'3" section and the WCHR Adult Amateur Challenge at the Capital Challenge Horse Show.*

The Playoff Invitations will be extended to the Top Six Riders in the 2021 Final WCHR Professional National Standings including points earned in the 2021 WCHR Professional Challenge and the 2021 Capital Challenge Horse Show. Should any of the top six professional riders be unable to compete or decline to participate, the next available rider in the Final Pro National Standings will be invited to compete, and so on to ensure six riders compete.\* A seventh Wild Card Spot will go to the Winner of the 2021 WCHR Pro Challenge if the winner is not already qualified in the Top Six of the Final National Standings. The score from the rider's first round of the Professional Challenge will count as the riders first score of the Playoff rounds. A score from the Professional Challenge is required to compete in the Pro Finals Playoffs.

The second round of the Playoffs will consist of a handy course on a horse of the rider's choosing, scored by three teams of judges under the open numerical system. Each team will present one score and the scores will be averaged each round. The horse chosen by the rider does not need to be the same mount that the rider competed on in the Professional Challenge. Fence heights of 3'5".

The final playoff standings will be based on the highest two round cumulative score with the Top Four Riders qualifying on to the Final Four.

\*In fairness to all potential competitors, the Top Six riders in the Final WCHR Professional National Standings must declare their intent to compete in the Pro Finals by

remitting the official form to USHJA staff or a designated WCHR Task Force member, no later than 10:00 a.m. Eastern time on Thursday October 3, 2021. After that date and time additional invitations may be extended to the next rider(s) in the Final WCHR Professional National Standings.

The top four riders will start the Final Four on a clean slate. They will show four horses provided by the Show over four different courses of 8-10 fences with fence heights set at 3'5". The order of go for the riders first round of the Final Four will be reverse order of the final standings of The Playoffs. The order of go for the horses will be determined prior to the class by random draw. For the next three rounds the horses will stay in the same order and the riders will rotate. Each rider will ride all four horses.

The class will be scored on the presentation of the horse and style of the rider using the Open Numerical Scoring system by three teams of two judges. Each Team will present one score for each round, the three teams scores will be averaged for a single round total. The rider with the highest four round cumulative score will be the 2021 World Champion Hunter Rider.

In the event of a tie after four rounds for first place only there will be a ride off to determine the winner. For all other ties judging team number one will be the tie breaking score.

#### 8. \$1,500 WCHR Children's Challenge

Invitations will be extended to the top six riders from each of the Children's Hunter sections at the 2021 Capital Challenge Horse Show. Should any rider finish in two or more of the top six placings in a section, invitations will be extended to the next highest finisher(s) to ensure that six individual riders receive invitations to compete.

Additionally, invitations will be extended to the top 10 nationally ranked WCHR Children's riders prior to the start of the show, the top six regionally ranked WCHR Children's riders from each of the eight WCHR regions and the winner of the 2020 WCHR Children's Challenge. See page 9 for WCHR membership criteria. Riders may compete on only one pony/horse. To be eligible, riders may not have participated in any hunter section where the fences exceed 3'5" (on any horse) after June 1, 2021. This Challenge is a one-round class. Fence heights of Horses-3'0", Large ponies-2'6", Small/Medium ponies-2'0". *Note: Junior 3'3" riders are eligible for the WCHR Children's Challenge at the 2021 Capital Challenge Horse Show as long as they have not shown in a hunter section where the fences exceed 3'5" after June 1, 2021. However, a horse-and-rider combination may not cross enter between the Junior 3'3" section, and the WCHR Children's Challenge or between the Junior 3'6" section and the WCHR Junior 3'3" Challenge at the 2021 Capital Challenge Horse Show.*

Invitations will be extended to the top 10 nationally ranked WCHR Developing Professionals prior to the start of the show and the top six regionally ranked WCHR Developing Professionals from each of the eight WCHR regions. The desired number of entries in the class will be 30. If necessary, additional spots will be filled by those Developing Pros who are not already qualified prior to the start of the class, based on their highest scoring round in any WCHR recognized Open Hunter Section at the 2021 Capital Challenge Horse Show. Riders may compete on only one horse. This Challenge is a two-round class in which the 12 highest scoring horse-and-rider combinations from the first round will be invited back for the second round. Fence heights of 3'3"

### **Developing Professional**

The Developing Professional Program was created to provide opportunities to professional riders. Developing Professional riders are also eligible for all WCHR Professional sections and awards and will automatically earn points in the Professional Category. In addition, Developing Professional riders will earn points from the Pre-Green Hunters (3'0" and/or 3'3") and the Performance Working Hunter 3'3" sections at WCHR Member Events. The WCHR has defined the following criteria for a 2021 Developing Pro:

- Rider has never placed in the top 10 of the WCHR Professional National Standings.
- Rider has never been a WCHR Professional Regional Champion.
- Rider has never won a Legacy Cup Restricted Professional Final.
- Rider has never won the Developing Professional Challenge at the Capital Challenge Horse Show.
- Rider has never won the Developing Professional National Title.
- Rider has never placed 1<sup>st</sup>-12<sup>th</sup> in the Professional Challenge during the WCHR Finals at the Capital Challenge Horse Show.
- Rider has never been Champion or Reserve Champion in a Professional Hunter section at 3'6" or higher at the following competitions: Devon, Capital Challenge, Pennsylvania National Horse Show, Washington International Horse Show and/or The National Horse Show.
- Rider has never competed and placed in an FEI Grand Prix Competition (excluding Young Riders).
- Riders must declare Developing Professional at the time of WCHR Application. All Developing Professional declarations are subject to review by the WCHR Task Force to ensure the integrity and spirit of the program are maintained.

Should any rider finish in two or more of the top eight placings in a section, invitations will be extended to the next highest finisher(s) to ensure that eight individual riders receive invitations to compete. Additionally, invitations will be extended to the top 10 nationally ranked WCHR
