# **USHJA Zone 1 Committee Meeting Minutes**

Monday January 14, 2019 - 4:00 p.m. ET

## I. Welcome and Roll Call

Ms. Dotoli called the meeting to order and April Hammond called roll. A quorum was met with ten committee members present.

#### II. Approve the minutes

*Ms.* Eidson motioned to approve the minutes from the March 26, 2018 meeting; Ms. Broda seconded and the minutes were approved.

## III. Annual Meeting Review

#### A. 2020 Zone Election

Ms. Dotoli overviewed the upcoming election and the projects that the committee needs to tackle this year. For the election, Ms. Dotoli would like for Ms. Eidson and Mr. Bahret to look into the details for what needs to be done. She would like this transition to be smooth and effective. Ms. Dotoli also informed the committee that she does not plan to run again for Committee Chair.

Ms. Dotoli updated the committee with the information that Ms. Broda has moved from a non-voting advisor to a voting member. Ms. Dotoli asked the committee for recommendations of people to add as non-voting advisors. She noted that Monica Hunt, Annie Dotoli, and Sheila Murphy were names discussed at Annual Meeting.

## **B.** TCP Clinic

The committee is looking to host another TCP Clinic. Ms. Dotoli stated that she has reached out to Mount Holyoke about having the clinic there. If the committee agrees on this location then she will continue conversation with them on dates and other details. She would like to replicate the clinic from 2017 because of its success. Monica Hunt expressed interest at the USHJA Annual Meeting with helping with the TCP Clinic. The committee is looking at November 10<sup>th</sup>-11<sup>th</sup> for the date of the clinic. Ms. Hinkle Russell and Ms. Broda stated that they would be willing to help in whatever way they can.

# C. Educational Forums

The committee would like to have an educational forum at a horse show. There would be a jumper course designer and those interested would help build the course, ask questions, listen to the course designer, and then the next day they can ride the course they set. Ms. Dotoli is discussing the implementation of this with a couple of competition managers. The forum would be free to members and not limited to zone 1. The committee would like to give some payment to the person funning the forum for their time. Ms. Dotoli would like to ask the host location provide some small refreshments.

# **D.** Hunter Forums

Ms. Dotoli requested the assistance of Ms. Foster and Ms. Eidson with the hunter forums. The committee would like to look into hosting at least one hunter forum. Ms. Dotoli mentioned discussing this further in the future but would like to start looking at potential locations.

# E. Affiliates

Ms. Dotoli noted that the topic of identifying affiliates was brought up at Annual Meeting. She would like to identify the smaller organizations (mostly in New England) and invite them to things like the forums and TCP clinic. She would like to bring them along and show them what the zone has to offer to the USHJA members. Ms. Dotoli requested that the committee members look into the associations in their states that aren't very big or well known. She requested the help of Mr. Bahret and Ms. Black with researching these organizations.

## F. Grants and Scholarships

The committee discussed the lack of interest in the Academic Grant and may potentially reallocate those funds to ensure more educational opportunities in the zone. Ms. Foster will spearhead the grants and scholarships. Ms. Hammond informed the committee of change to online review system.

Ms. Foster seconded and the committee voted unanimously in approval.*
