<u>From O'Hare International Airport to Hotel:</u> Get on I-190 E, Take I-90 W to IL-59 S/Illinois Rte 59 S in Hoffman Estates. Take exit 59 from I-90 W, turn left onto IL-59 S/Illinois Rte 59, in 10.8 miles turn right onto IL-64 W/E North Ave, in 2.4 miles turn right onto Pheasant Run, turn right and hotel will be on the left <u>From Chicago Midway Airport to Hotel:</u> Get on I-55 S in Stickney from S Cicero Ave, Continue on I-55 S. Take I-294 N, I-88 W and I-355 N to IL-64 W/W N Ave/E North Ave. in Lombard. Take exit 27 from I-355 N for IL-64/North Ave, turn left onto IL-64 W/W N Ave/E North Ave, in 1.3 miles keep right to continue on E North Ave, in 10 miles turn right onto Pheasant Run, turn right and hotel will be on the left

<u>From Hotel to Show Grounds:</u> Turn right onto E Main St, 1.1 miles turn right onto N Kirk Rd, in 1.6 miles continue onto Dunham Rd, in 2 miles turn left onto Lamplight Trail into Lamplight Equestrian Center.

\$385 = 'r' and applicant session, online registration completed <u>on or before May 20, 2022</u>. \$460 = 'r' and applicant session, online registration completed <u>after May 20, 2022</u>.

\$50 = Print and ship notebook directly to clinic <u>on or before June 3, 2022.</u>
\$75 = Print and ship notebook directly to clinic <u>after June 3, 2022.</u>

# REFUND

If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee.
