1. How are you currently involved in the Sport? Please list your equestrian experience. I currently own an Adult Jumper and compete in the .90-1.0 meter and Adult Equitation classes. I have been a lifelong equestrian, getting hooked on the sport at 8 years old when I was sent to summer camp. Since then, I have participated in the sport in the following ways: As a junior I rode and showed on the New England circuit in the Equitation, Jr. Hunter and Jr. Jumper divisions. Prior to attending college, I groomed for a top hunter jumper trainer who also had a spot on the USET with his jumpers (Bernie Traurig). During college I taught in the public lesson program held at my college's riding stables (Smith College), coached and IHSA team for 3 years (Becker Jr. College), and ran summer riding programs (Camp McCready and Camp Glen Arden) before settling on a career in the investment banking business. As an Amateur during the1990's and early 2000s I showed on the "A" circuit throughout Carolina's, Georgia and Florida competing primarily in the hunters through the 1980s and 1990s before taking a break due time constraints with my career. In 2010 I retired from my banking career and wanted to find a path back to the horses. I had always had an interest in horse care and began to acquire some business interests in products that were noninvasive, non-prescriptive had had proven efficacy. I formed MacKinnon products and through that entity now own the brands Ice Horse, Hoof Wraps Brand and SteriHoof. We sell direct to the consumer, through tack shops and to veterinarians throughout the United States and around the world. The well-being of horses is a true passion of mine and as a project during COVID I started a series of free, non-promotional webinars called For The Love Of The Horse focused on horse health. I reached out to others in the horse community and asked if they would help promote the webinars and the result was quite stunning. Top veterinarians, clinicians a researchers donated their time for these events. Several well know brands with a stake in the health horse space and several media outlets partnered with us to promote the webinars. The content was objective and non-promotional. I produced 15 episodes and had over 16,000 horse owners and care givers sign up to watch and learn with us with 80% of the attendees signed up for more than one event. I keep the site live with webinars available free of charge as a resource to horse owners and caregivers. Please visit www.lovethehorse.com to see the content. In late 2023 I joined the board of the Arizona Hunter Jumper Association and am currently serving as Vice President.
