IV. Member Comments – 2019 Zone 9 Specifications

After reviewing the member comments on the Zone 9 specifications, the committee discussed making changes to the specifications as they are currently written.

The committee decided to make the following changes to the current Children's Hunter

Pony Zone 9 Specifications for Cross Entry of the rider:

Children's Hunter Pony riders may compete on a maximum of one (1) Children's Hunter horse section at the same competition and in any class not to exceed 3'0" (Exception: Pony Jumpers). Green and Regular Hunter Pony riders may compete on a maximum of one (1) two (2) additional pony in the Children's Hunter Pony section at the same competition.

The committee also added the following to the Children's Hunter Pony Cross Entry specifications for Horse and Rider Combination:

The same pony and rider may not cross enter at the same competition into any other rated section at the same competition. (Exception: Pony Jumpers).

Ms. Von Zimmermann motion to approve the new specifications. Ms. Marriner-Smith seconded and the committee unanimously voted to approve.

VII. Adjourn

There being no further business, Mr. Von Zimmermann motioned to adjourn; Ms. Marriner-Smith seconded and the meeting was adjourned at 10:55 a.m. PT.
