

## USHJA YOUNG HUNTER PONY CHAMPIONSHIPS SPECIFICATIONS

## I. Competition Requirements

- A. The USHJA Young Hunter Pony championships may be offered at Federation Licensed Premier, National, Regional I or Regional II rated competitions.
- B. Competition Management will collect and remit to USHJA a \$25 per entrant fee.
- C. Competition management will remit complete overall results, including prize money awarded, to USHJA and the Federation within 10 days of the conclusion of the competition.
- D. The Young Hunter Pony championships is a featured event of the competition, and must be presented as such with regard to arena size and location, jump quality, decorations, footing and ring preparation, lighting, etc. The ring used must have spectator seating, a quality sound system, and a dedicated announcer.
- E. Entry fee shall be determined by competition management.

# II. Membership and Participation Requirements

- A. Riders, owners, and trainers must be current Active members of the Federation and USHJA on or before the first day of the competition.
- B. Ponies must be recorded with the Federation and registered with USHJA on or before the first day of the competition.
- C. Owners must possess a current measurement card or valid measurement form issued by the Federation.
- D. Ponies must be handled by junior exhibitors in all phases of a class, except in breeding classes inhand.
- E. Ponies shown by a junior cannot be shown by an adult at the same competition, except in breeding classes in hand and in accordance with HU110.
- F. Division of Classes. Hunter Pony 4 & 5 Year Olds 2', Hunter Pony 4 & 5 Year Olds 2'3", Hunter Pony 6 & 7 Year Olds 2', Hunter Pony 6 & 7 Year Olds 2'3" and Hunter Pony 6 & 7 Year Olds 2'6" (exhibitor's choice) to be made up of one model, one under saddle class and two over fences classes. An under saddle class for 5 Year Olds & under for ponies not competing in the 4 & 5 Year Olds over fences classes will also be offered.

## III. Prize Money and Awards

- A. Prize money must meet the minimum requirement of \$1,000 per class, except the model which will award \$500.
- B. Prize money must be paid to the sixth place as followed:

1<sup>st</sup> \$330 4<sup>th</sup> \$110 2<sup>nd</sup> \$220 5<sup>th</sup> 100 3<sup>rd</sup> \$150 6<sup>th</sup> \$90 Model prize money must be paid to the sixth place as followed:

1 <sup>st</sup> \$165	4 <sup>th</sup> \$55
2 <sup>nd</sup> \$110	5 <sup>th\$</sup> 50
3 <sup>rd</sup> \$75	6 <sup>th</sup> \$45

- C. If there are less than 6 entries in the class, any remaining prize money not awarded may be split and awarded equally to all entrants that place in the class.
- D. Awards will be presented at the discretion of the USHJA and include 1st through the 8th place.

# IV. Judging Requirements

- A. To be judged on performance, soundness and conformation, suitability or manners.
- B. Conformation to count for 30% in the second over fences class.
- C. An open numerical judging system must be used.
- D. Ponies that are not sound are ineligible for an award. Ponies will be jogged for soundness at the conclusion of over fences rounds.
- E. The announcer or ringmaster will line up entries before awarding the ribbons.
