Judges are asked to walk the course when possible and where there are striding options, the judges are asked not to penalize an option that might be used to achieve the best result appropriate to the *track taken and the* individual horse/rider combination. *JP134* (*The competition round*) and *JP135* (*Timing*) will apply. No work-off is required. Two refusals will incur elimination.
- 5. If 50 or more entries compete, the class will be pinned with two firsts, two seconds, two thirds, and so on through two eighths, with full points going to each placing.

EQ109 Appointments

- 1. Protective headgear. All riders must wear protective headgear. See GR801.2. While competing in a class, if a rider's chin strap becomes unfastened, the rider may stop, re-fasten the chin strap and continue his/her performance without penalty or elimination. A judge may, but is not required, to stop a rider and ask them to refasten a chin strap which has become unfastened, again without penalty to the rider. Headgear must be free from non-traditional adornment.
- 2. Attire. Riders are required to wear conservatively colored coats (black, blue, green, grey or brown) which are free from adornment which in the judge's opinion is overly distracting. Shirts must have a choker, similar collar or tie. Breeches may be buff, canary, tan, rust or white.
- 3. Spurs, crops or bats are optional but if used must be a conservative color.
- 4.1. Personal. Exhibitors and judges should bear in mind that at all times entries are being judged on ability, rather than on personal attire Riders should wear coats of any tweed or Melton for hunting (conservative wash jackets in season), breeches or jodphurs and boots. Conservative colored protective headgear with no additional adornments in accordance with GR801 is mandatory. While competing in a jumping class, if a rider's chin strap becomes unfastened, the rider may stop, re-fasten the chin strap and continue his/her round without penalty or elimination. A judge may, but is not required, to stop a rider and ask them to refasten a chin strap which has become unfastened, again without penalty to the rider. Spurs, crops or bats are optional Judges may penalize contestants who do not conform. When management permits Hunter or Hunter Seat Equitation riders to ride without jackets, riders must wear traditional, short, or long-sleeved riding shirts with chokers or ties. Polo shirts, and chaps are not permitted except in unjudged warm-up classes. Management or Judge may eliminate an exhibitor who is inappropriately attired. Inappropriate attire. When management permits Hunter/Jumping Seat Equitation riders to ride without jackets, riders must wear traditional, short, or long-sleeved riding shirts with chokers or ties. Polo shirts, and full chaps are not permitted except in unjudged warm-up classes. Management or Judge may eliminate an exhibitor who is inappropriately attired.
- 5. Tack. Regulation snaffles, pelhams and full bridles, all with cavesson nose bands, are recommended. Two-ring bits, three-ring bits and gags are not considered conventional equipment for hunter seat equitation classes. A judge at his own discretion can penalize a horse with nonconventional types of bits or nose bands. Martingales are permitted in classes over obstacles and in the jumping phase of classes requiring both jumping and flat work. Changing of bits between phases is permissible.
- 6. Stirrups must be silver in color or non-colored stainless steel. Riders entering the ring with stirrups that do not conform will be eliminated. (Exception: quick release safety stirrups and stirrups with jointed branches are permitted when the remaining area of the stirrup branch is silver in color or non-colored stainless steel and does not unduly obscure the judge's view of the rider's foot in the stirrup.)
- 2.Tack. Regulation snaffles, pelhams and full bridles, all with cavesson nose bands, are recommended. Two-ring bits, three-ring bits and gags are not considered conventional equipment for hunter seat equitation classes. A judge at his own discretion can penalize a horse with nonconventional types of bits or nose bands. Martingales are permitted in classes over obstacles and in the jumping phase of classes requiring both jumping and flat work. Changing of bits between phases is permissible.
- 3-7. No mounted exhibitor may wear or carry an electronic communication device (i.e., cellular telephone, pager, walkie talkie, etc.) while in the competition ring. The penalty for wearing or carrying a forbidden device if observed by the judge may be elimination from the class during which the device was worn or carried. Exception: A handicapped participant may use electronic devices if, prior to the class, he/she presents to the USEF Steward written justification from treating personnel setting forth the necessity of the equipment.
- 4.8. A rider will be eliminated for competing with a tail wrap.
- 5. The use of stirrups that have entirely black branches is not permitted in any Equitation class. The use of stirrups which have entirely black branches will automatically result in elimination.

a. In Hunter Seat equitation, Regulation snaffles, pelhams and full bridles, all with cavesson nose bands, are required recommended. Judges may penalize, but may not eliminate, a horse or pony that competes in an snaffle, pelham or full bridle that is unconventional. Two-ring bits, three-ring bits, and gags are not considered conventional equipment for hunter seat equitation classes. Judges must eliminate a horse or pony that competes in an illegal bit or a noseband other than a cavesson. Illegal bits include, but are not limited to, two rings, three rings, gags (other than the hunter gag), et cetera. Judges may penalize, but may not eliminate, a horse or pony that competes in an snaffle, pelham, or full bridle that is unconventional. Judges must eliminate a horse or pony that competes in an illegal bit or noseband. Legal nosebands include leather cavesson, flash and figure eight. Illegal nosebands include but are not limited to drop nosebands.

c. Boots and conservative colored bandages are permitted. Type of saddle is optional. Martingales are permitted in classes over obstacles and in the jumping phase of classes requiring both jumping and flat work. Changing of bits between phases is permissible.

- a. No mounted exhibitor may wear or carry an electronic communication device (i.e., cellular telephone, pager, walkie talkie, etc.) while in the competition ring. The penalty for wearing or carrying a forbidden device if observed by the judge may be elimination from the class during which the device was worn or carried. Exception: A handicapped participant may use electronic devices if, prior to the class, he/she presents to the USEF Steward written justification from treating personnel setting forth the necessity of the equipment.
- b. Electronic communication devices used for purposes of coaching, etc., between competitors and individuals outside the ring shall be prohibited in all classes.
- c. Exhibitors who have a chronic condition may apply for a Presidential Modification exempting them from the provisions of this rule in accordance with GR152. Riders may not use these devices in over fences classes.
- d. An exhibitor who has a chronic condition and has previously been granted at least one annual presidential modification related to the condition, may submit an application for approval of a special three-year presidential modification related to the same condition. The application must be accompanied by sufficient supporting documentation that the condition is unlikely to improve during the three-year period.

EQ110 Class Routine

1. Over Obstacles. The performance begins when the horse enters the ring. Except for refusals jumping faults of the horse are not to be considered unless it is the result of the rider's ability. No rider can be eliminated until ten riders have completed the course, or a number equal to the ribbons being awarded. (Exception: three refusals, fall of horse and/or rider and off course). The following will result in elimination: a) fall of horse and/or rider (rider shall not remount in the ring); b) three cumulative refusals (exceptions: USEF Medal Finals, USEF Pony Medal Finals, Maclay Finals, USEF Talent Search class and the WIHS Equitation Jumper phase, exhibitors will be eliminated after two cumulative refusals); c) off course; and d) trotting or cantering through the in-gate or out-gate. In the event of an elimination, the rider must exit the ring immediately. If elimination occurs during a ride-off, the competitor is placed last of all those chosen for the ride-off, but placed before any riders not participating (see EQ113). The following constitute major faults and can be cause for elimination: a) a refusal; b) crossing your track; A track is established once a horse has landed from a fence or completes a required test and follows the horse until the consecutive fence is jumped or the next test is executed. Upon completion of each consecutive fence or performance of the next test, the track is erased. Crossing a track between obstacles and/or required tests shall constitute a disobedience and will be penalized by the judge(s).

Exceptions: 1. A course diagram that requires a rider to cross his track. 2. Snake or multiple panel jumps that are jumped consecutively. b) c) loss of stirrup; e) d) trotting while on course when not part of a test; and d) e) loss of reins. Each competitor may circle once before approaching the first obstacle. He then proceeds around course keeping an even pace throughout. If a refusal occurs in a double or triple, competitors must rejump all obstacles in the combination. Any or all competitors can be called back to perform at a walk, trot and canter or to execute any appropriate tests included in class requirements (see EQ112 and EQ113). If a rider does not attempt a part of the test (e.g., fails to back, fails to halt) a score of 50 shall be given for the first occurrence. If a rider attempts the test, but encounters difficulty (e.g., loss of counter lead, breaking to the canter in front of a trot fence), up to 10 points may be deducted depending on severity, for each occurrence. In the event that a rail comes down, first score the knockdown within the context of the round. Unless the knock down is caused by a MAJOR rider error, it should not be considered a MAJOR riding EQ fault.

EQ110 Class Routine

1. Over obstacles.

- a. The performance begins when the horse enters the ring.
- b. Each competitor's round will be scored on the rider's performance.
- c. Each competitor may circle once before approaching the first obstacle. He then proceeds around the course keeping an even pace
 - d. If a refusal occurs in a double or triple, competitors must re-jump all obstacles in the combination.
- e. The judge will determine a base score for each competitor's performance. A knock down penalty of four (4) points per rail will be deducted from the base score.
 - f. In classes with a time allowed, a one (1) point deduction per second over the time allowed will be deducted from the base score.
 - g. The following constitute major faults:
 - 1. A refusal.
 - 2. Trotting on course when not part of a test.
 - h. The following constitute faults at the judge's discretion:
 - 1. A loss of stirrup(s).
 - 2. A loss of rein(s).
- i. An eliminated rider must leave the ring immediately. If elimination occurs during a ride-off, the competitor is placed last of all those chosen for the ride-off, but placed before any riders not participating (see EQ113). The following actions will result in elimination:
 - 1. Fall of horse and rider (rider shall not remount in the ring).
- 2. Three cumulative refusals. Exceptions: Riders will be eliminated after two refusals in the U.S. Hunter Seat Medal Finals, U.S. Pony Medal Finals, Maclay Finals, USEF Talent Search class and the WIHS Equitation Jumper phase.
 - 3. Off course.
 - 4. Trotting or cantering through the in-gate or out-gate.
- j. Any or all competitors can be called back to perform at a walk, trot and canter or to execute any appropriate tests included in class requirements (see EQ112 and EQ113). If a rider does not attempt a part of the test (e.g., fails to back, fails to halt) a score of 50 shall be given for the first occurrence. If a rider attempts the test, but encounters difficulty (e.g., loss of counter lead, breaking to the canter in front of a trot fence), up to 10 points may be deducted depending on severity, for each occurrence.

2. Flat Classes and Flat Phases.

- a. In Hunter Seat or Jumping Seat Equitation flat classes or phases, judges must work competitors in groups of twenty (20) or less.
- b. Light contact with the horse's mouth is required
- c. Competitors shall proceed at least once around the ring at each gait and, on command, reverse and repeat. The order to reverse can be executed by turning either toward or away from the rail. Entries then line up on command.
 - d. All tests must be on the flat.
- e. In addition to the class requirements of EQ112 and EQ113, in Intermediate, Open Equitation classes for riders 12 years of age and older, ASPCA Maclay classes, and all U.S. Hunter Seat Medal classes, riders may be asked to work collectively without stirrups.
- f. In addition to the class requirements of EQ112 and EQ113, in Open Equitation classes for riders 12 years of age and older, ASPCA Maclay classes, and all U.S. Hunter Seat Medal classes, judges may call for more advanced flatwork such as shoulder in, shoulder out, haunches in, haunches out, and changing direction collectively.
- 3. Outside assistance will be penalized at the judge's discretion.
- 4. In cases of broken equipment or loss of shoe, the competitor must continue or be eliminated. Exception: see EQ109.1 for protective headgear.
- 5. The number of competitors who complete the course will be used to determine the number of entrants for the increment system.
- 6. In any two-phase equitation class, i.e. the WIHS, Maclay and the USEF Talent Search, a rider must complete both phases to be eligible for a ribbon in the overall standings. Exception: U.S. Hunter Seat Medal see EQ112.9.
- 7. No medal class with a national year-end finals may run concurrently with any other class or section in the same ring. Exception: Pony Medals and WIHS Equitation Hunter Phase.

The following constitute major faults and can be cause for elimination: a) a refusal; b) loss of stirrup; c) trotting while on course when not part of a test; and d) loss of reins. Each competitor may circle once before approaching the first obstacle. He then proceeds around course keeping an even pace throughout. If a refusal occurs in a double or triple, competitors must rejump all obstacles in the combination. Any or all competitors can be called back to perform at a walk, trot and canter or to execute any appropriate tests included in class requirements (see EQ112 and EQ113). If a rider does not attempt a part of the test (e.g., fails to back, fails to halt) a score of 50 shall be given for the first

occurrence. If a rider attempts the test, but encounters difficulty (e.g., loss of counter lead, breaking to the canter in front of a trot fence), up to 10 points may be deducted depending on severity, for each occurrence. In the event that a rail comes down, first score the knockdown within the context of the round. Unless the knock down is caused by a MAJOR rider error, it should not be considered a MAJOR riding fault. BOD 1/19/13 Effective 12/1/13. 2. Not to Jump. Competitors shall enter ring and proceed at least once around ring at each gait and, on command, reverse and repeat. Riders may be asked to work collectively without stirrups in Intermediate, 14 and over and Open classes. The order to reverse can be executed by turning either toward or away from the rail. Light contact with horse's mouth is required. Entries then line up on command. Any or all rid- ers may be required to execute any appropriate tests included in class requirements (EQ112 and EQ113). All tests used must be on the flat. Judges are encouraged to call for at least two tests of the top contestants. 3. Outside Assistance. Outside assistance will be penalized at the judge's discretion. 4. In cases of broken equipment or loss of shoe, the competitor must continue or be eliminated. 5. The number of competitors who complete the course will be used in determining the number of entrants for the increment system. 6. In any two-phase equitation class, i.e. WIHS, Maclay, and the USEF Talent Search, a rider must complete both phases to be eligible for a ribbon in the overall standings. Exception USEF Medal, see EQ112.9. 7. No medal class with national year-end finals may run concurrently with any other class or section in the same ring. 1. In all cases, the hunter eligibility and green status of the horse or pony are the responsibility of the owner. [HU103.1 The green status of a horse is the responsibility of the owner.]

PROPOSED CHANGE

- 2. Determining Hunter eligibility for horses. Hunter eligibility for a horse begins when a horse of any age, competes for the first time in any over fences class with jumps set at three feet (3'0") in height or higher in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America.
- 3. Determining Green or Pre-Green Status for horses. Horses that have not broken their Pre-Green or Green Status must jump less than their regulation height or their Green Status will be broken. The Green or Pre-Green status of a horse is determined by the following factors in competition experience at Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America:
- a. The height of fences (determined by the class, section or division specifications) over which a horse or pony has competed.
- b. The number of competition years a horse has competed at regulation height. A horse that has competed in such classes for two (2) or more competition years, without receiving a reinstatement, is no longer eligible to compete in the respective Pre-Green or Green section.
- 4. Determining Hunter eligibility for ponies. Hunter eligibility for a pony begins when a pony of any age, competes for the first time in any over fences class with jumps set at 2'3" or higher for small ponies, 2'6" or higher for medium ponies and 2'9" or higher for large ponies in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America.
- 5. Determining Green Status for ponies. Ponies that have not broken their Green Status must jump less than their regulation height or their Green Status will be broken. The Green status of a pony is determined by the following factors in competition experience at Hunter or Hunter /Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America:
- a. The height of fences (determined by the class, section or division specifications) over which a pony has competed.
- b. The number of competition years a pony has competed at regulation height. A pony that has competed in such classes for one (1) or more competition years, without receiving a reinstatement, is not longer eligible to compete in the Green section.
- 6. In all cases, fence heights will be determined by the specifications of each section regardless of whether or not the fences are actually set at the regulation height.
- 7. [HU103] 3. If a competition starts prior to or on November 30th, **Pre-Green and** Green status at the start of the competition is **are** maintained throughout the competition.
- 8. Green Status sections are divided into Pre-Green Horse (3' and 3'3"); First Year Green, Second Year Green and Green Conformation; and Green Pony (2'3", 2'6" and 2'9). Each status is defined below.
- 9. Pre-Green Horse Status.
- [HU106] 3. Pre-Green Unless USHJA Zone Committees submit their specifications by August 1st to the Federation, the following specifications will apply:
- [HU106.3] a. A Pre-Green Hunter is a horse of any age in his first or second year of showing over 3' 0" (0.925m) or 3'3" (1.00m) fences that has never competed over fences of 3'6" (1.07m) or higher. Upon receipt by the owner of written notification of a 1st Year Green Reinstatement a horse may return to Pre-Green if it meets all other eligibility requirements of Pre-Green.
- a. A Pre-Green Hunter is a horse of any age in his first or second year of showing over fences set at 3'0" or 3'3" in height that has never competed over fences set at 3'6" in height or higher in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America. Upon receipt by the owner of written notification of a First Year Green Hunter Reinstatement a horse may return to Pre-Green Hunter if it meets all other eligibility requirement of Pre-Green Hunter.
- [HU106.3] b. Pre-Green status begins when a horse competes in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fence heights set at 3'0" (0.925m) or higher.

[HU106.3] c. A horse may not have competed in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fences set at 3'6" (1.075m) or higher prior to or during their Pre-Green years. Exception: Horses six years of age and under competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Pre-Green Hunters. Eligibility is the responsibility of the owner.

[HU106.3] d. A horse is eligible to compete as a Pre-Green hunter for a maximum of two years regardless of their age.

b. A horse is eligible to compete as a Pre-Green Hunter for a maximum of two (2) years regardless of age.

[HU106.3] e. Horses may compete in either or both the 3'0" (0.925m) or 3'3" (1.00m) Pre-Green hunter section during their two (2) years of eligibility. Horses may not cross enter between 3'0" (0.925m) and 3'3" (1.00m) Pre-Green sections at the same competition (see USHJA Zone Specifications for exceptions).

- c. Horses may compete in either or both the 3'0" or 3'3" Pre-Green Hunter section during their two (2) years of eligibility. Horses may not cross enter between 3'0" and 3'3" Pre-Green sections at the same competition. Exception: In USHJA Zone 9, horses may cross enter between 3'0" and 3'3" Pre-Green sections at the same competition.
- d. Once a horse begins competing in a class that restricts Pre-Green status, it may no longer compete in any Jumper class at 1.05 meters or above held at a USEF or Equine Canada Licensed competition in North American or it will lose its pre-green status.

[HU105.7] a. Pre-Green Reinstatement. A Pre-Green reinstatement may be granted one time. A horse is not eligible for a Pre-Green reinstatement if it has competed in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fences set at 3'7" (1.10 m) or above. Exception: Horses six years of age and under competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Pre-Green Hunters without the need for a green reinstatement. Horses that have competed in a USHJA International Hunter Derby are not eligible for reinstatement of Pre-Green status. See HU106 for Pre-Green status definition.

e. Pre-Green Reinstatement. A Pre-Green reinstatement may be granted one time. A horse is not eligible for a Pre-Green reinstatement if it has competed over fences set at 3'7" in height or higher in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America. Horses that have competed in a USHJA International Hunter Derby are not eligible for reinstatement of Pre-Green status.

[HU106.3] f. No jogging is required.

- f. No jogging is required.
- 10. Green Hunter Horse Status for First Year, Second Year and Green Conformation.

[HU103] 1. A Green Hunter is a horse of any age in its first or second year of showing in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions in which the specifications require horses to jump 3'6" (1.075m) or higher, regardless of whether or not the fences are actually set at 3'6" (1.075m) or higher. Exception: Horses six years of age and under competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Pre-Green or First Year Green Hunters and horses seven years of age competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Second Year Green Hunters. The green status of a horse is the responsibility of the owner.

[HU103] 2. A horse's green status is considered to be broken once it competes over fences 3'6" (1.075m) or higher.

a. A Green Hunter is a horse of any age that is eligible to compete in the Green Hunter Section. A horse's Green Hunter eligibility, regardless of age, begins the first time the horse competes in any over fences class with jumps set at 3'6" in height or higher in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America.

[HU103.1] a. When shown in a Green section a horse in its first year of showing over fences 3'6" (1.075m) or higher must be shown as a First Year Green horse.

b. A horse in its first year of showing in the Green Hunter section over fences 3'6" or higher must be shown as a First Year horse when it is shown in Green Hunters or Green Conformation Hunters.

[HU103.1] b. When shown in a Green section a horse in its second year of showing over fences 3'6" (1.075m) or higher must be shown as a Second Year Green horse.

c. A horse in its second year of showing in the Green Hunter section over fences 3'6" or higher must be shown as a Second Year horse when being shown in the Green Hunters.

[HU105.7] b. First Year Green Reinstatement. A First Year Green reinstatement may be granted one time. A horse is not eligible for a First Year Green reinstatement if it has competed in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fences set at 3'7" (1.10m) or above. Exception: Horses six years of age and under competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Green Hunters without the need for a green reinstatement. A horse is not eligible for a First Year Green reinstatement if it has competed in the US Junior Hunter Championship. See HU103 for Green status definition.

- d. Once a horse begins competing in a class that restricts Green status, it may no longer compete in any Jumper or Hunter/Jumping Seat Equitation class at 1.20 meters or above held at a USEF or Equine Canada Licensed competition in North America or it will lose its Green status.
- e. A First Year Green reinstatement may be granted one time. A horse is not eligible for a First Year Green reinstatement if it has competed in any over fences class with jumps set at 3'7" in height or higher in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America. A horse is not eligible for a First Year Green reinstatement if it has competed in the US Junior Hunter Championship.

[HU105.7] c. Second Year Green Reinstatement. A Second Year Green reinstatement may be granted one time. Horses seven years of age competing over fences of 3'6" (1.075m) or higher in jumper classes at FEI competitions will retain eligibility as Second Year Green Hunters without the need for a green reinstatement. See HU103 for Green status definition.

f. A Second Year Green reinstatement may be granted one time.

HU104.1 Green Status - Pony Hunter

11. Green Pony Status.

[HU104] 1. A green pony is a pony not exceeding 14.2 hands of any age, in its first year of showing in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions that require ponies to jump the regulation height or higher for its respective section. The green status of a pony is the responsibility of the owner.

a. A green pony is a pony not exceeding 14.2 hands of any age, which is eligible to compete in the Green Pony section. A pony's Green Hunter eligibility, regardless of age, begins the first time the pony competes in any over fences class with jumps set at 2'3" or higher for small ponies, 2'6" or higher for medium ponies and 2'9" or higher for large ponies in Hunter or Hunter/Jumping Seat Equitation classes or sections held at a USEF or Equine Canada Licensed competition in North America.

[HU104.1] a. Showing in Canada over fences at or higher than the regulation height for the pony's section under Equine Canada rules breaks the pony's green status for the purpose of this Rule and Federation rules whether or not the regulation height for the pony's section under Equine Canada rules is less than, equal to, or greater than the regulation height for the pony's section under Federation rules.

[HU104.1]b.Once a pony has broken its green status in one Pony Hunter section (i.e., small, medium, large) it will not regain its green status by moving into another Pony Hunter section.

b. A pony is eligible to compete as a Green Pony for a maximum of one (1) year regardless of age or change to measurement status. A pony that has changed height sections in its green year may complete the green year at its new height.

[HU104] 2. If a competition starts prior to or on November 30, Green Pony status at the start of the competition is maintained throughout the competition.

[HU104] 3. Ponies who have not broken their Green Status must jump less than their regulation height in open classes or their Green Status will be broken.

[HU104] 4. In its first year of showing at regulation height or higher, a green pony may also compete in the Regular Pony Hunter section at its respective height.

- c. In its first year of showing at regulation height or higher, a green pony may also compete in the Regular Pony Hunter section at its respective height.
- d. Once a pony begins competing in any class that restricts Green status, it may no longer compete in any Jumper class held at a USEF or Equine Canada Licensed competition in North America or it will lose its Green status.

[HU105.7] d. Pony Green Reinstatement. A Pony Hunter Green reinstatement may be granted one time. A pony is not eligible for a green reinstatement if it has competed in the US Hunter and/or Jumper Pony Championship. See HU 104 for Green Pony Hunter status definition.]

e. A Pony Hunter Green reinstatement may be granted one time. A pony is not eligible for a green reinstatement if it has competed in the US Hunter and/or Jumper Pony Championship.

[HU105 Green Status - Reinstatement]

12. Green Reinstatement.

[HU105.1] d. Until written notification has been received from the Federation that the reinstatement has been granted, a horse or pony cannot return to compete in the section for which the reinstatement application was made. A horse or pony cannot return to compete in the section for which the reinstatement application was made until written notification has been received from the Federation that the reinstatement has been granted. [HU105] 1. Green Reinstatement. A horse or pony's eligibility to compete in sections that are restricted by experience may be reinstated for a future competition year provided that: A horse or pony's eligibility to compete in sections that are restricted by experience may be reinstated for a future competition year provided that:

[HU105.1] a. The horse or pony was not shown at the regulation height or higher at more than four (4) competitions prior to September 1st of the current competition year.

a. The horse or pony was not shown at the regulation height or higher at more than four (4) competitions prior to September 1st of the current competition year.

[HU105.1]b. The horse or pony was not shown at the regulation height or higher on or after September 1st of the current competition year.

b. The horse or pony was not shown at the regulation height or higher on or after September 1st of the current competition year.

[HU105.1] c. The horse or pony must stop competing at the regulation height or higher immediately upon application for reinstatement.

c. The horse or pony does no longer competes at the regulation height or higher immediately upon application for reinstatement.

[HU105.1] e. The horse or pony is otherwise eligible for a reinstatement under Federation rules.

d. The horse or pony is otherwise eligible for a reinstatement under Federation rules.

[HU105] 2. The Federation recorded owner must submit the green reinstatement application, which must reach the Federation office on or before November 30th of the year of withdrawal. The request must be made during the year in which green status was broken.

e. The Federation recorded owner has submitted the green reinstatement application, which must reach the Federation office on or before November 30th of the year of withdrawal. The request must be made during the year in which green status was broken.

[HU105] 3. The green reinstatement application must include the following:

[HU105.3] a. The processing fee (fee schedule available on www.usef.org)

[HU105.3] b. A list of competitions with dates where the horse or pony competed at its regulation height or higher.

[HU105.3] c. The horse's or pony's name and Federation recording number.

[HU105.3] d. The name, USEF number and signature of the Federation recorded owner.

[HU105.3] e. Green reinstatement applications with missing or incomplete information will be automatically denied.

[HU105] 4. If the horse or pony is not actively recorded at the time of request, it must be recorded/renewed at that time. If the horse or pony is not recorded/renewed at the time of

application, the reinstatement request will be automatically denied.

[HU105] 5. The owner will receive written notification from the Federation stating whether the horse or pony has been granted a green reinstatement.

[HU105] 6. In the event an owner of a horse or pony is not satisfied with the decision, the owner may submit a written appeal to be heard by the Federation Hearing Committee at a \$100 appeal fee. An appeal does not guarantee the reinstatement will be granted.

- b. Pre-Green status begins when a horse competes in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fence heights set at 3'0" (0.925m) or higher.

A horse may not have competed in any hunter, jumper, hunter seat equitation or jumping seat equitation classes held at Federation Licensed competitions, Equine Canada competitions and/or FEI competitions with fences set at 3'6" (1.075m) or higher prior to or during their Pre-Green years. - d. In a section with three (3) classes, the under saddle will count half points towards champion and reserve.
- 7.-5. Small Hunter
- a. Fences set at 3'.
- b. Championships must be offered in accordance with HU147.

- b. Electronic communication devices used for purposes of coaching, etc., between competitors and individuals outside the ring shall be prohibited in all classes.
- c. Exhibitors who have a chronic condition may apply for a Presidential Modification exempting them from the provisions of this rule in accordance with GR152. Riders may not use these devices in over fences classes.
- d. An exhibitor who has a chronic condition and has previously been granted at least one annual presidential modification related to the condition, may submit an application for approval of a special three-year presidential modification related to the same condition. The application must be accompanied by sufficient supporting documentation that the condition is unlikely to improve during the three-year period.

HU127 Attire

- 1. Protective headgear. All riders must wear protective headgear. See GR801.2. While competing in a jumping class, if a rider's chin strap becomes unfastened, the rider may stop, re-fasten the chin strap and continue his/her round without penalty or elimination. A judge may, but is not required, to stop a rider and ask them to refasten a chin strap which has become unfastened, again without penalty to the rider.
- 2. Attire. Riders are required to wear conservatively colored coats (black, blue, green, grey or brown) which are free from adornment which in the judge's opinion is overly distracting. Shirts must have a choker, similar collar or tie. Breeches may be buff, canary, tan, rust or white.

 1. 3. Formal Attire. Riders are required to wear scarlet or dark coats; white shirts with white stock; white, buff or canary breeches. and protective headgear. See GR801.2. While competing in a jumping class, if a rider's chin strap becomes unfastened, the rider may stop, re-fasten the chin strap and continue his/her round without penalty or elimination. A judge may, but is not required, to stop a rider and ask them to refasten a chin strap which has become unfastened, again without penalty to the rider. Members of the Armed Services or the Police may wear the Service Dress Uniform.
- 2. 4. Inappropriate attire. When management permits Hunter or Hunter Seat Equitation riders to ride without jackets, riders must wear traditional, short, or long-sleeved riding shirts with chokers or ties. Polo shirts and **full** chaps are not permitted except in unjudged warm-up classes. Management or Judge may eliminate an exhibitor who is inappropriately attired.

- 2. The following are considered major faults.
- a. Knockdown
- b. Refusal

- d. Crossing the track. A track is established once a horse has landed from a fence or completes a required test and follows the horse until the consecutive fence is jumped or the next test is executed. Upon completion of each consecutive fence or performance of the next test, the track is erased. Crossing a track between obstacles and/or required tests shall constitute a disobedience and will be penalized by the judge(s). Exceptions 1. A course diagram that requires a rider to cross his track. 2. Snake or multiple panel jumps that are jumped consecutively.
- d. e. Dangerous jumping
- e. f. Addressing a jump coming to a stop in front of a jump in order to show the jump to the horse.
- f. g. Completely missing a lead change
- g. h. Adding or eliminating a stride in an in and out.
- h. i. Breaking stride, or Trotting while on course. (Exceptions-Where posted on the course diagram i.e. trot jumps, steep banks, etc, and also as outlined above in HU135.1l. Striking off on a wrong lead on the courtesy circle.)

- 1. The USHJA, at its discretion may choose to hold a National or East and West Championship for Amateur Owner Hunters. This competition is designed to encourage and promote the basic training and development of Amateur Owner Hunters. The Championship must be offered for the Amateur Owner Hunter 3'6 and the Amateur Owner Hunter 3'3" section. Championship(s) must be run in accordance with USHJA specifications found at USHJA.org.
- 2. Eligibility.
- a. The horse must be recorded with the Federation and registered with USHJA on or before the first day of the Championship.
- b. The owner of record of the horse must be an Active member in good standing of the Federation and USHJA, i.e. horses must be shown in accordance with GR1102 and GR1108 in order to be eligible to qualify.
- 3. Points

All points are based on values below. In classes that have less than 10 entries, the point values will be one-half of what is listed below.

There is a Federation rule effective 12/1/14 which will potentially result in a significant reduction in the number of competitions currently permitted to host International Hunter Derby classes due solely to the new requirement of Premier rated competitions to pay a minimum of \$24,000 in hunter prize money. There are currently Premier competitions, which due to geographic location and constituency concentration, will not be able to meet the \$24,000 Premier prize money requirement, but will meet or exceed the remainder of the Premier rated competition standards. This situation would reduce member and competition organizer opportunity to participate in this program.
