I. Welcome and Roll Call

Ms. Pearson called the meeting to order and called roll. With ten committee members present, a quorum was met.

II. Approve the minutes

members. Ms. Mulkey stated it has been modeled after the 2021 USHJA HTC held in the East, West and Central locations for this year. Ms. Tredennick and Ms. Mulkey have been working on putting this together for Zone 4 Finals. They would like to ask the Committee to approve \$2,500 for awards for this Zone 4 HTC. *Ms. McCarroll made a motion to approve \$2,500 for awards for the Zone 4 HTC to be held at 2021 Zone 4 Finals. Mr. Pellegrini seconded the motion. The motion passed with Ms. Mulkey and Ms. Tredennick abstaining.* Ms. Tredennick asked anyone who knows barns that will be going to Zone 4 Finals to let her know and she will reach out to them regarding the HTC and the format. Anyone who would like to help out with this can let Ms. Tredennick and/or Ms. Mulkey know.
