Attendees must complete the clinic with a passing score on specified requirements as outlined in the <u>USEF Licensed Officials Policies and Procedures</u> to receive clinic credit. Notebook materials will be sent via email two weeks prior to the clinic. A hard copy notebook may be purchased from USHJA to ship directly to the clinic for an additional fee. The deadline to register online for the clinic is **January 12**. Officials and applicants interested in registering after this date must contact the Licensed Officials Coordinator at USHJA at 859-225-6705 to register and are subject to a late fee. **Attendance is strictly limited.** All attendees of USHJA Licensed Officials Clinics are required to be Active/Competing members of USHJA.

ATTENDANCE

- <u>Attendance is strictly limited</u>, on a first come, first serve basis. Please complete the online registration form in advance of the **January 12, 2024 deadline**. Available clinic spots may become filled before the early registration deadline.
- Attendees must sign in at the beginning and end of each session to receive credit for the clinic. If you arrive
 more than one hour later than the scheduled starting time, or leave before the scheduled adjournment, you
 will not receive credit for attending the clinic.
- Online registrations will receive an email follow up from USHJA staff shortly after form is submitted.
- You are required to review notebook material from USHJA prior to the clinic. Materials will be distributed two weeks in advance. You will need to print or have electronic access to it during the clinic. Notebooks will not be distributed at the clinic site unless purchased in advance.

DIRECTIONS

FEES

\$270 = Online registration completed on or before January 12, 2024.

\$50 = Print and ship notebook directly to clinic on or before January 26, 2024.

\$75 = Print and ship notebook directly to clinic **after January 26, 2024.**

REFUND If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
