ATTENDANCE

- <u>Attendance is strictly limited</u>, on a first come, first serve basis. Please complete the online registration form in advance of the **January 12, 2024 deadline**. Available clinic spots may become filled before the early registration deadline.

 more than one hour later than the scheduled starting time, or leave before the scheduled adjournment, you
 will not receive credit for attending the clinic.

FEES

REFUND If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
