ATTENDANCE

AIRPORT

Bluegrass Airport – Lexington, KY (LEX) – 9 miles Louisville Muhammad Ali International Airport (SDF) – Louisville, KY – 73 miles from Lexington Cincinnati Northern Kentucky International Airport (CVG) - 75 miles from Lexington

DIRECTIONS

<u>FROM DOWNTOWN LEXINGTON</u>: Take Newtown Pike (922) northbound approximately 3.5 miles to Aristides Blvd. and turn left. Hotel will be on the right.

<u>FROM LOUISVILLE, KY</u>: Travel eastbound on Interstate 64 for approximately 70 miles to Interstate 75. Take Exit 75 southbound towards Lexington. Take exit 115 and turn right. In 0.4 miles, turn right onto Aristides Blvd. The hotel will be on the right.

<u>FROM CINCINNATI, OH</u>: Travel southbound on Interstate 75 towards Lexington for approximately 75 miles to exit 115 and turn right. In 0.4 miles, turn right onto Aristides Blvd. The hotel will be on the right.

FEES \$270 = Online registration completed <u>on or before April 28, 2023</u>. \$350 = Online registration completed <u>after April 28, 2023</u>.

\$50 = Print and ship notebook directly to clinic <u>on or before May 5, 2023.</u>
\$75 = Print and ship notebook directly to clinic <u>after May 5, 2023.</u>

REFUND If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
