## DIRECTIONS

From George Bush Intercontinental Airport to Hotel: Head west on Jetero Blvd/Will Clayton Pkwy in 1.6 miles continue onto John F Kennedy Blvd, in 1.7 miles take the exit on the left toward TX-8 Beltway/I-45, continue onto John F Kennedy Blvd, 0.8 miles, slight right toward N Sam Houston Pkwy E/Texas 8 Beltway Frontage Rd, turn right onto N Sam Houston Pkwy E/Texas 8 Beltway Frontage Rd and take the ramp onto TX-8 Beltway W, Follow TX-8 Beltway W and Sam Houston Tollway W to the exit onto I-10 W toward San Antonio, take exit 754 towards Kirkwood Rd, Merge onto Interstate 10 Frontage Rd W, 0.4 miles turn right, turn right at dead end, hotel is on the left.

From Hotel to Show Grounds: Turn right onto Interstate 10 Frontage Rd W/Old Katy Rd, 0.5 miles take the ramp onto I-10 W, in 9.8 miles take exit 743B to merge onto TX-99 S, in 3.2 miles take the Cinco Ranch Blvd exit, turn left onto Cinco Ranch Blvd, in 1.4 miles turn left onto Mason Rd, in 0.3 miles Great Southwest Equestrian Center will be on the right.

## **FEES**

\$385 = 'r' and applicant session, online registration completed on or before March 3, 2023.

\$450 = 'r' and applicant session, online registration completed after March 3, 2023.

\$50 = Print and ship notebook directly to clinic on or before March 10, 2023.

\$75 = Print and ship notebook directly to clinic after March 10, 2023.

## **REFUND**

If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
